

“Justice for All”- J6 Prison Choir

The “Justice for All” song (and video) is a powerful collaboration featuring President Donald J. Trump and the J6 Prison Choir. The project serves as a patriotic anthem and a call to action to support these political prisoners targeted for their belief that rampant cheating, shenanigans, and possible foreign interference in the 2020 election must be investigated, and that Trump honestly won the 2020 election instead of Biden.

- The purpose of “Justice for All” by the J6 Prison Choir was supporting wrongfully imprisoned patriots. The song was created to raise funds for the families of those incarcerated after January 6; victims of a politically motivated setup, or false flag by perhaps the FBI or perhaps Antifa, or perhaps a combination of numerous Trump dissenters. Proceeds provided legal aid and financial support to help these families navigate an unjust legal system.
- The J6 Prison Choir consisted of men in the D.C. jail, who sang “The Star Spangled Banner” every night before bed, encouraging one another throughout their solitary confinement, and terrible jail treatment. This project symbolizes their unbroken spirit despite the harsh conditions. Their singing was recorded over a jailhouse phone in February, 2023.
- Donald J. Trump recorded the Pledge of Allegiance at his Mar-a-Lago residence, in February 2023 for the project.
- The collaboration was spearheaded by Ed Henry, with the support from Kash Patel. Both saw the song as a way to give a voice to those silenced by a biased justice system.
- The song was released March 2, 2023, on Apple Music, Spotify, and YouTube. The music video premiered on Steve Bannon’s “War Room” podcast, the next day. Vinyl records were sold on the J6 Prison Choir’s website, and the song soared to No. 1 on billboard’s Digital Song Sales chart and iTunes in March, with 33,000 downloads from March 10-16, outperforming Miley Cyrus. It garnered 442,000 US streams and 25,000 radio impressions.
- The Biden Justice Department had federally charged around 1583 defendants as of January 20, 2025.
- Trump offered full, complete, and unconditional pardons for around 1559 individuals, commuted sentences for 14 individuals, and dismissed around 300 cases that had not yet reached sentencing.

Remembering and Honoring Our POWs and MIAs



In solemn recognition of the sacrifices made by our Prisoners of War (POWs) and those Missing in Action (MIAs), we dedicate this moment to honor their courage, resilience, and unwavering commitment to our nation. Their absence is a profound reminder of the cost of freedom, and we vow to never forget their service or the families who await their return. In front of the podium this evening is a small table given a "Place of Honor". It is set for one, symbolizing the fact that members of our Armed Forces are not able to be with us this evening. With this gesture, we remember our POW's/MIA's. They are unable to be with their loved ones and families tonight, so we join together to pay our humble tribute to them, and bear witness to their continued absence. Those who have served and those who are currently serving, are ever mindful that the sweetness of enduring peace has always been tainted by the bitterness of personal sacrifice. We are compelled to never forget that while we enjoy our daily pleasures, there are others who have endured and may still be enduring the agonies of pain, deprivation, and internment.

A Table Set for One: A Symbol of Remembrance

The "Table Set for One" is a poignant tradition observed at military ceremonies, dining facilities, and memorial events to symbolize the absence of our POWs and MIAs. This small, solitary table serves as a powerful visual tribute, meticulously arranged with specific items, each carrying deep meaning. Below is a detailed explanation of the table and its elements:

The Table: The table is small, set apart from others, symbolizing the isolation and vulnerability of those held captive or missing. Its modest size reflects the singular focus on each absent service member.

White Tablecloth: A pristine white tablecloth drapes the table, representing the purity of the intentions and sacrifices made by our POWs and MIAs in service to their country.

Single Place Setting: A single plate, napkin, and set of utensils are arranged, signifying that the table is reserved for one absent individual, emphasizing their unique sacrifice.

Empty Chair: The chair at the table remains empty, a stark reminder of the absence of the POW or MIA who cannot join us. It stands as a silent tribute to their missing presence.

Inverted Glass: The drinking glass is turned upside down, symbolizing that the absent service member cannot partake in a toast or share in the fellowship of the meal.

Red Rose in a Vase: A single red rose, often tied with a red ribbon, is placed in a vase on the table. The rose represents the blood shed by these heroes and the love of their families and comrades who keep their memory alive.

Candle: A lit candle, often white or red, symbolizes the light of hope that burns eternal for the safe return of our POWs and MIAs or for the resolution of their fate.

Slice of Lemon: A slice of lemon is placed on the plate or near it, representing the bitter fate endured by those who are missing or held captive.

Pinch of Salt: A small pile or pinch of salt is sprinkled on the plate, symbolizing the tears shed by families, friends, and comrades awaiting the return of their loved ones.

Black Napkin or Ribbon: A black napkin or ribbon may be included, signifying the sorrow and uncertainty surrounding the fate of those unaccounted for.

POW/MIA Flag or Symbol: Often, a POW/MIA flag or emblem is placed near or on the table, reinforcing the commitment to never forget those who are missing or imprisoned.

The Bible: The Bible represents the strength gained through faith to sustain us and those lost from our country, founded as one nation under God.

This carefully arranged table is not merely a display but a sacred space for reflection. It invites all who see it to pause, remember, and honor the sacrifices of those who have not returned. The ceremony accompanying the table often includes a moment of silence or a reading to underscore its significance, ensuring that the memory of our POWs and MIAs remains alive in our hearts.

“Return to Hand Counting”

In October of 2022, in response to Mike Lindell’s call to “get rid of machines,” Linda Rantz asked herself, “and replace them with what?” She took action to find out, starting with a visit to Louisiana where that team was demonstrating their hand count method. Returning to Missouri, Linda immersed herself in Mis-

souri’s laws, learning that not only was hand counting permitted in her state, but the laws dated back to 1977.

Based on Missouri statutes, Linda began to write an ‘outline’ of the Missouri method hand count process. It grew into a 300-page eManual, which includes 60 pages of process and a multitude of links to supporting documents, resources, and laws, all with the hopes of giving others the information they need to speak with their election officials. The guide, “Missouri Elections: Return to Hand Counting,” is available as a free download on ReturntoHandCounting.com, and will be available in a soft-cover book in the future.

Linda continues to promote and teach hand counting around the country, having already trained groups in states beyond Missouri, including Georgia, Pennsylvania, Nevada, Oregon, and more!

*Local J6er -
“Saving Missouri”*

Isaac Yoder and his wife Kelly live in Vernon County, Missouri with their 3 children Gracia, Zeb, and William. Isaac is the middle child of 9 children. Raised in a Christian family, he was homeschooled and learned a love and appreciation for our country. He took a special interest in early American history and soon began creating costumes to replicate our founding fathers. He was always inspired by their Christian character, courage and deep devotion and the very obvious hand of God's providence guiding our forefathers in the founding of this nation. He finds any excuse to dress up in colonial attire. He attended the Stop the Steal rally in November of 2020 in DC with some of his family members. And when the President put out the call to come to D.C. on January 6th, he said, "oh, we are going to that!" Again, he donned his Patriot garb. So his father, brothers, sister-in-law along with a niece and nephew, drove to Washington DC to attend the rally. Late in the afternoon, he peacefully and prayerfully entered the Capitol for a few minutes and then left for home. In February he was contacted by the FBI and had his colonial costume confiscated, along with all his cell phone data. In August of 2021 he was officially charged and placed on pre-trial probation. After a year and a half of court hearings, he was finally able to take his case to trial in March of 2023. He waved his right to a jury in order to have a bench trial hoping that a judge in his profession of the law would be able to see through political bias and rhetoric at play. Unfortunately, Judge Royce Lamberth went right along with the MSM narrative and political bias and found Isaac guilty of all charges.

He received the highest sentence at the time for the 4 misdemeanors: 1 year in prison and 1 year probation. He ended up serving 6.5 months in a federal prison with 2.5 months of home confinement. There were many rough days and nights, tears and heartache, but through all of this, he and his family have experienced the goodness and faithfulness of God. Seeing God's hand move and prayers answered, brought a deeper faith and love for the Lord not only in Isaac, but in his wife and children. He is looking forward to see where he and his family fit in, in the fight to reclaim our nation. He is excited to see what God is going to do next.





J6 SPEAKERS:

Mark and Jalise Middleton

“Saving Our Country”

Mark and Jalise Middleton are average people, that have lived an honest, quiet life. That is, until January 6, 2021 when they made the decision to go to the capital in protest to what they suspected was a stolen election. They prayed together outside the barriers. A Capitol police officer reached over the barriers, grabbed Jalise's winter scarf and pulled her to the barrier using the scarf around her neck and pepper sprayed both of them while tightly holding her scarf so she couldn't get away

Later, after they got out of there and went home, the Biden-weaponized FBI violated the Middleton home and family privacy, raiding them on April 21, 2021 and left their lives in shambles. The Middleton's went through their own kangaroo trial and wound up unjustly in prison, until Trump pardoned them along with all the other 1700 January 6 political prisoners, “J6ers”.

Jalise and Mark did what they could to help fellow-violated patriots, and organized American-PatriotRelief.org. This organization helped and still helps the J6 political prisoners through their legal battles. The Middleton's made sure each political prisoner had a welcome group to feed them, encourage them, and have a place to stay when they were released after their pardons, often in the middle of the night in the blistering cold.

Particular jailers targeted the J6ers, and provided brutal and weaponized torture treatment: incessant propaganda, tapping, screaming, or beatings, disgusting food, unsanitary conditions, solitary confinement for months, and even years, violating America's "cruel and unusual punishment". Now, after being pardoned, the Middleton's continue with their organization, raising money and awareness for these 1700 political prisoner J6ers, who due to this mistreatment, need intense counseling, spiritually, emotionally, and financially. The Middleton's currently live in Texas, where they are helping put together a Retreat location for those mistreated J6ers that desperately need some time and place to recuperate, and get some needed rest, counseling and encouragement. They drove hundreds of miles to share with us tonight.

How we can come along side of them? How can you help? In order to do that, we all need to know the truth of what happened on January 6, 2021. Through their faith in Jesus Christ, the Middleton's are speaking out publicly to the atrocities being covered up by governing authorities.



Abraham Lincoln

Abraham Lincoln (February 12, 1809 – April 15, 1865) was the 16th President of the United States, serving from March 1861 until his assassination in April 1865. Lincoln led the United States through its greatest constitutional, military, and moral crises—the American Civil War—preserving the Union, abolishing slavery, strengthening the national government and modernizing the economy. Reared in a poor family on the western frontier, Lincoln was self-educated, and became a country lawyer, a Whig Party leader, Illinois state legislator during the 1830s, and a one-term member of the United States House of Representatives during the 1840s.

President Lincoln endured extraordinary pressures during the long Civil War. He carried on despite generals who weren't ready to fight, assassination threats, bickering among his Cabinet members, huge loss of life on the battlefields, and opposition from groups such as the Copperheads. However, Lincoln remained brave and persevered. He didn't give in to the pressures to end the war early. He kept fighting until the Confederacy was defeated.

Despite common lore, the Emancipation Proclamation actually freed few people. It did not apply to slaves in the Border States of Missouri, Kentucky, Maryland, and Delaware; nor did it affect slaves in southern areas already under Union control. Naturally, the states that had seceded did not act on Lincoln's orders. But the proclamation showed Americans — and the world — that the war was being fought to end slavery.

Although the Emancipation Proclamation did not immediately free a single slave, it changed the way black men were accepted during the war. Black men could join the Union Army and Navy. The liberated could become the liberators. By the end of the war, nearly 200,000 black soldiers and sailors fought for the Union and freedom.

EARLY LIFE AND EDUCATION: Lincoln's early years were defined by hardship and self-education. Growing up in frontier Kentucky and later Indiana, he had less than a year of formal schooling. However, his voracious appetite for knowledge led him to study books like the Bible, Aesop's Fables, and Robinson Crusoe. By his teens, he was known for his sharp intellect and storytelling. Lincoln worked as a rail-splitter, farmhand, and flatboat operator, developing a strong work ethic and physical resilience. In 1830, his family moved to Illinois, where he began his path to public life.

ACHIEVEMENTS: Lincoln's achievements are monumental:

- **Preservation of the Union:** His leadership ensured the United States remained intact during its greatest crisis.
- **Abolition of Slavery:** The Emancipation Proclamation and 13th Amendment ended centuries of enslavement.
- **Gettysburg Address:** This brief speech crystallized American ideals of democracy and equality.
- **Homestead Act (1862):** Signed into law, it granted land to settlers, promoting westward expansion.
- **Morrill Act (1862):** Established land-grant colleges, advancing education.
- **Transcontinental Railroad:** Authorized during his presidency, it connected the nation economically.

Lincoln's moral compass, humility, and resolve made him a transformative leader. His legacy endures in America's commitment to freedom and unity.

History of the American Flag

For more than 200 years, the American flag has been the symbol of our nation's strength and unity. It's been a source of pride and inspiration for millions of citizens. And the American Flag has been a prominent icon in our national history. Here are the highlights of its unique past.

On January 1, 1776, the Continental Army was reorganized in accordance with a Congressional resolution which placed American forces under George Washington's control. On that New Year's Day the Continental Army was laying siege to Boston which had been taken over by the British Army. Washington ordered the Grand Union flag hoisted above his base at Prospect Hill. It had 13 alternate red and white stripes and the British Union Jack in the upper left-hand corner (the canton).

In May of 1776, Betsy Ross reported that she sewed the first American flag.

On June 14, 1777, in order to establish an official flag for the new nation, the Continental Congress passed the first Flag Act: "Resolved, That the flag of the United States be made of thirteen stripes, alternate red and white; that the union be thirteen stars, white in a blue field, representing a new Constellation."

Between 1777 and 1960, Congress passed several acts that changed the shape, design and arrangement of the flag and allowed for additional stars and stripes to be added to reflect the admission of each new state.

- Act of January 13, 1794 – provided for 15 stripes and 15 stars after May 1795.
- Act of April 4, 1818 – provided for 13 stripes and one star for each state, to be added to the flag on the 4th of July following the admission of each new state, signed by President Monroe.
- Executive Order of President Taft dated June 24, 1912 – established proportions of the flag and provided for arrangement of the stars in six horizontal rows of eight each, a single point of each star to be upward.
- Executive Order of President Eisenhower dated January 3, 1959 – provided for the arrangement of the stars in seven rows of seven stars each, staggered horizontally and vertically.
- Executive Order of President Eisenhower dated August 21, 1959 – provided for the arrangement of the stars in nine rows of stars staggered horizontally and eleven rows of stars staggered vertically.

Today the flag consists of thirteen horizontal stripes, seven red alternating with six white. The stripes represent the original 13 colonies, the stars represent the 50 states of the Union. The colors of the flag are symbolic as well: Red symbolizes Hardiness and Valor, White symbolizes Purity and Innocence and Blue represents Vigilance, Perseverance and Justice.
